OFFICIAL WAIVER & RELEASE OF LIABILITY FOR GLIDE SURF SCHOOL EQUIPMENT HIRE CUSTOMERS.

DO NOT SIGN THIS DOCUMENT WITHOUT READING IT CAREFULLY IN ITS ENTIRETY. BY SIGNING THIS DOCUMENT YOU GIVE UP IMPORTANT LEGAL RIGHTS. SURFING AND STAND UP PADDLE BOARDING (referred as SUP throughout) IS AN ATHLETIC ACTIVITY, THE PARTICIPATION OF WHICH INVOLVES VARIOUS RISKS. PLEASE READ AND UNDERSTAND THIS DOCUMENT.

THIS IS A LEGAL DOCUMENT. MY SIGNATURE IS MY ACKNOWLEDGEMENT OF THE CONTENTS OF THIS CONTRACT. I WILL NOT SIGN THIS DOCUMENT UNLESS I FULLY UNDERSTAND AND AGREE TO BE BOUND BY ITS CONTENTS.

(1) I know how to swim 50m and I am in Good Health: My swimming skills are above those of a novice, I can maintain my head above water when my feet do not make contact with the bottom for extended periods of time and I am competent of self rescue. Likewise, I am in good physical and mental health, I am not under the influence of any drugs, alcohol, or any substances which may impair my swimming skills or my ability to take and follow instructions. I am not pregnant nor am I suffering from any spinal or skeletal defect, hearing, vision or balance impairment or other physical impairment. I understand that the foregoing representations as to my physical condition are being relied upon by the Glide Surf School. I hereby agree to follow all rules, regulations, and instructions of the Glide Surf School while renting their equipment.

(2) Surfing and SUP may be dangerous and I accept and assume such risk: I am aware that open water activities in general, and surfing and SUP specifically, involve inherent risks. I may damage my belongings, get hurt, get injured, drown or even lose my life. I further acknowledge that I have voluntarily chosen to rent equipment from the Glide Surf School. I willingly and voluntarily assume all risks and hazards in surfing and SUP and beach related activities until the conclusion of the equipment rental period. This includes, but not limited to those involving, (1) loss of control of surfboard, malfunction of the surf/SUP board, falls from the surf/SUP board, collision with other participants, equipment, other surf/SUP boards, and any other man made or natural obstacles; (2) submersion in water, drowning; (3) encounters with animals, marine life, plant life, rocks and insects; (4) exposure to outdoor ocean environment; (5) assistance in lifting and/or carrying surf/SUP equipment. I understand and acknowledge that the above list is not meant to be complete or exhaustive, and that other unforeseen and unanticipated risks, known or unknown, may also exist and result in damage, injury, illness, disease or loss of life. (6) Any damage or loss to any of the Glide Surf School equipment will be covered by paid for in full by the hirer. This will be based on the current trading price +VAT and any delivery charges for the same or equivalent similar model.

(3) My right to claim liability against the Glide Surf School has been waived: In consideration for the Glide Surf School agreeing to provide me with equipment rental I agree that I shall not make a claim, or bring any action against, sue, or hold responsible, the Glide Surf School, its owners, employees, associates, or expect, require, or pursue them, to be held accountable for any damages.

(4) I have read this document in its entirety and it is my intention that it be broadly construed in favour of the Glide Surf School in the event of any ambiguities, which shall be resolved in the Glide Surf School's favour. I understand that I am assuming all the risks inherent in this surfing or SUP activity, and that I may be injured, become ill, or even lose my life as a result. I understand that this is a release of any and all claims. I understand that this is the entire agreement between me and the Glide Surf School, and that no representations have been made to me by the Glide Surf School outside of this agreement. I voluntarily sign my name as evidence of my acceptance of all the provisions in this release and my agreement to be bound by them.
